The Grant County Board of Supervisors meeting was called to order at 10:00 a.m. by County Board Chairman Robert Keeney. The Pledge of Allegiance was recited.

County Clerk Tonya White verified that the meeting was held in compliance with the open meeting law, having been posted in the Administration Building, Courthouse, on the county website and published in the Herald Independent.

Roll Call was taken with fourteen (14) members present in the room: Gary Ranum, Gary Northouse, Robert Keeney, Roger Guthrie, Joseph Mumm, Adam Day, Rick Sanson, Carol Beals, Diane Nelson, Roger Lange, John Beinborn, Lester Jantzen, Mike Timmerman and Brian Lucey.

Robert Scallon and Patrick Schroeder asked to be excused. Kathy Kopp advised that she would be late.

Approval of Agenda: Gary Northouse, second by Joseph Mumm made a motion to approve the agenda. Motion carried by voice vote.

Approval of Minutes: Roger Guthrie, second by John Beinborn made a motion to approve the minutes from the July 15, 2025 meeting. Motion carried by voice vote.
